

SUNSAIL 2025 ANNAPOLIS BOAT SHOW SWEEPSTAKES

OFFICIAL RULES

NO PURCHASE OR OBLIGATION NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. ALL FEDERAL, STATE, PROVINCIAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED OR OTHERWISE RESTRICTED BY LAW.

The "2025 Annapolis Boat Show Sweepstakes" (the "Sweepstakes"), sponsored by Sunsail ("Sponsor"), begins at 10:01 a.m. Eastern Time (ET) on October 9, 2025 and ends at 5:00 p.m. (ET) on October 12, 2025 ("Sweepstakes Entry Period").

ELIGIBILITY: The Sweepstakes is open to any person (the "Entrant") who is: (i) a legal resident of the United States of America (including the District of Columbia, but excluding New York), and 21 years of age; or (ii) a legal resident of Canada (excluding the Province of Quebec) who is of or over the age of majority in the province in which he or she resides. Age and residency requirements must be met at the time of entry into the Sweepstakes. Persons who are employees of the Sponsor, its respective parent companies, affiliates, subsidiaries, agents and the immediate families (spouse, children, parents and siblings) and/or those living in the same household of such persons at any time before or during this Sweepstakes are not eligible to enter. In the event of any dispute or ambiguity regarding the eligibility of an Entrant, Sponsor reserves the right to determine, in its sole discretion, whether the Entrant satisfies the eligibility requirements of the Sweepstakes. The decisions of Sponsor are final and binding in all respects. Limit one entry per person.

permanently disqualify from any sweepstakes it sponsors from any person it believes has intentionally violated these Official Rules; and/or (ii) cancel the Sweepstakes if it becomes technically corrupted, (including if a computer virus or system malfunction inalterably impairs its ability to conduct the Sweepstakes), and to select winners from among all eligible entries received prior to withdrawal.

HOW TO ENTER: To enter, visit the website <https://www.sunsail.com/regattas-racing-events/annapolis-competition> (the "Website") during the Sweepstakes Entry Period to complete the entry form (which will require information such as the Entrant's email address, phone number and other contact information). By submitting this form the Entrant will automatically be entered in the drawing for the prizes described in the "Prize" section below if no winner of the "Prize" has been drawn as part of the live Spin-To-Win game available at the Sunsail booth in Annapolis prior to the end of the Boat Show.

All entries become the property of Sponsor and will not be acknowledged. In the event of a dispute over the identity of an online entrant, entry will be deemed submitted by the holder of the e-mail account. The authorized account holder is deemed as the natural person who is assigned to an e-mail address by an internet access provider, service provider or other organization that is responsible for assigning e-mail addresses or the domain associated with the submitted e-mail address. Mass entries or entries generated by a script, macro or use of automated devices will be disqualified. No mechanical reproductions permitted. Incomplete entries are void. SELECTION OF WINNER: On October 15, 2025, if no winner of the "Prize" has been drawn as part of the live Spin-To-Win game at the Annapolis booth, One (1) potential winner will be drawn at random from all of the eligible entries received via the website to receive the "Prize" (as such prize is described in the "Prize" section below). The random drawing will be conducted at the Sponsor's office (as provided in the "Sponsor" section below). The potential winner will be notified via telephone, mail and/or email (at Sponsor's discretion) using the contact information provided by the Entrant on the entry form, within seven (7) days of the drawing. The potential winner must respond to such notification within forty-eight (48) hours, and execute and return, prior to and as a condition of receiving the indicated prize, applicable tax documentation, an affidavit of eligibility and liability release and, except where prohibited by law, a publicity release. The potential winner must return

such documentation within ten (10) days of date of issuance. Prizes will be awarded after receipt by Sponsor of properly executed documents.

If a potential winner is a Canadian resident, then such potential winner must correctly answer, unaided, a time-limited mathematical, skill-testing question to be provided by the Sponsor in addition to compliance with the requirements described above.

There is a total of (1) prize available to be won. One (1) GRAND PRIZE: The Grand Prize winner will receive a 6-night, 7-day charter aboard a Sunsail bareboat catamaran yacht up to 45' in length in the British Virgin Islands for up to eight (8) persons, including the winner. Charter must take place before September 30, 2026 and will be scheduled at the Sponsor's discretion and pending availability. Thanksgiving and Christmas Holiday Peak Dates are excluded from this sweepstakes. If the guests charter the yacht without the named winner, then one or more guests must be 21 years of age or older. The cost of the charter giveaway pertains to the yacht fleet-line cost only.
